Update on Central Table Bargaining Today the Ontario Labour Relations Board convened a hearing in Toronto to determine which issues will be dealt with at central bargaining tables and which would be dealt with at local tables for both Support Staff and Teacher/Occasional Teacher negotiations.

As was reported in previous Bargaining Bulletins, the government and the trustees' associations have proposed a more extensive list of items to be bargained centrally than OSSTF/FEESO is willing to agree to.

It is unclear when the Labour Board will issue a decision. As soon as that decision is received, a Bargaining Bulletin will be issued to inform members.
