2018 Spring Staffing Process - Teachers

This year's spring staffing process has come to a close. Please note that any vacancies posted outside of the spring staffing process are open to <u>all</u> contract teachers. The following are approximate statistics from the Spring Staffing Process:

- Current Seniority List: 636.17 FTE (660 teachers)
- Staffing Allocation for 2018-19 schools: 588.83 FTE
- Current Recall List: 31 teachers (12.83 FTE Recall)
- Current SLOA List: 11 teachers (4.17 FTE SLOA)
- Placement Meeting #1: 29.17 FTE vacancies of which 7.83 FTE filled by SLOA, 10.33 FTE filled by transfer, 7.50 PT Inc
- Placement Meeting #2: 18.33 FTE vacancies of which 2,83 FTE filled by SLOA, 2.00 FTE by transfer, 2.50 PT Inc
- Displacement Process:
 - 18.33 FTE vacancies of which 1.67 FTE were filled by those displacing
 - most senior able to displace is Sept 2005,
 - 1.0 FTE positions were displaced

Qualified/Qualifying for a Change in Category?

If members submitted their documents to OSSTF Certification and advised the Employer, in writing, that they have done so **on or before June 30** they will be paid retroactively to **Jan. 1** once they submit a copy of their updated rating statement to the Board. Benefit Coverage: Post Secondary Dependants; Travel

Your OSSTF Benefits plan includes coverage while travelling out of the country. Details of coverage is available on the OTIP website when you log in. Ensure you have your OTIP benefits card handy as it has contact information should you need to make a claim from abroad.

Teachers are reminded to call the District Office immediately should they receive a "below standard" performance appraisal or a "development needed" performance appraisal

Benefit Coverage for Post Secondary Dependants

Dependent children coverage ends at age 21. However, a child who is a full-time student attending an educational institution recognized under the Income Tax Act is also considered an eligible dependent until the age of 25 as long as the child is entirely dependent on you for financial support. Employment Insurance – Summer Applications

Some of our members employed on a 10-month basis and our Occasional Teachers may be applying for EI benefits at the end of June. The following instructions are being sent out as a reminder in an attempt to limit EI denials and to process EI appeals in a timely manner. Members are instructed to apply for benefits at the time they experience the lay-off, regardless of the communication they receive from Services Canada. Should they be denied, members must appeal within 30 days of receiving notification of denial of benefits. They should state that they are a member of OSSTF and will be represented by OSSTF at the appeal hearing. Members should also clearly state on their appeal that they are, for example, an occasional teacher. Members should then contact Provincial OSSTF office.

OSSTF Certification Appeals Board - Call for Member

The Certification Appeals Board, made up of three members of the Certification Council, is tasked to hear appeals from OSSTF members of rulings made by the Certification Department, to interpret Certification Regulations and to make decisions in individual cases based on the merits of the overall documentation. The Provincial Executive is seeking one Member-at-Large to serve on the Appeals Board for a three-year term.

Interested applicants should submit a letter of application indicating their suitability for this position and outlining specifically, their demonstrated experience working with issues related to certification.

The Certification Appeals Board members meet as part of the Certification Council approximately seven times per year. Additional meetings may occur as required, based on appeals. Applicants must be able to obtain time release from their employers. All time release and travel costs will be covered by Provincial Office. A Message from OTIP: OSSTF Benefits Eligibility Information for Teachers There have been several inquiries regarding how OSSTF Benefit eligibility applies over the summer months, so for your information and reference, I would like to confirm the following:

• For permanent teachers, as long as their employment status does not change, they are eligible for continued coverage over the summer months, with no change to the member contribution for July and August.

- For permanent teachers who are laid off at the end of this school year, benefit eligibility and funding continues until August 31, 2018. Commencing September 1, 2018 members on a recall list are eligible to continue to participate in the plan on a 100% member paid basis for up to 24 months. Members on permanent lay off are eligible to continue to participate in the plan on a 100% member paid basis for up to 6 months.
- For members who retire or terminate their employment, coverage will cease at the date of their retirement or resignation. For example, if the retirement or resignation date is June 28th, coverage will cease as of midnight on this date and will not continue over the summer months.

PAR Leader Duties - Report Cards

OSSTF would like to reiterate that, in accordance with Article 19.02, PAR leaders **should not** "assess teachers' comments made on students' formal reports". This means reviewing such comments (grammar, syntax, format, etc.), making a determination as to the appropriateness of the comment, making such corrections or advising the teacher or administration that such a comment is either acceptable or not acceptable. If PAR leaders are directed by their administration to do so, we ask that they comply and inform the local Branch Steward. However, OSSTF has no objection to...

- □ PAR leaders, in their respective program area meetings, informing members regarding the administration's expectations of report card comments (grammar, syntax, format, curriculum links, appropriateness etc)
- PAR leaders mentoring teachers who request aid in developing report card comments
- PAR leaders reviewing the spread of marks for classes in their program area

- A reminder to all OSSTF members -Members should not be participating in interviews/evaluations when hiring personnel
